Sub: Sanction for release for an amount of Rs.22.65 Crore as devolution funds to the
ULBs of General Areas of Assam under the award of Fifth ASFC for the year 2016-17

Sir,
I am directed to convey the sanction of the Governor of Assam to an amount of Rs.22.65 Crore
(Rupees Twenty Two Crore and Sixty Five lakh) only as 02nd installment against the grant of Rs.72.05 crore as
recommended by 05th Assam State Finance Commission for the year 2016-17 as devolution fund for ULBs in
General Areas of Assam. A statement showing Districtwise breakup of amount for each ULB is shown at
Annexure I (enclosed).

The Sanction is issued based on the following criteria:

1. The Distribution list is prepared for Rs.22.65 Crore (Rupees Twenty Two Crore and Sixty Five lakh) on
the basis of the projected devolution fund for the year 2016-17 shown at Statement No. S-9 (page no.
374-376 of report of 5th ASFC) i.e., Rs. 22.65 Crore (72.56-50.00 = 22.65 Crore).
2. The amount shall be drawn by Deputy Commissioners of the ULBs concerned and shall be disbursed to
each of the ULBs in their accounts duly registered under PFMS and the amount shall be transferred
through the ECS after ascertaining that all pending UCs of each releases under the award of State
Finance Commission has been submitted.
3. The ULBs shall have overall responsibility for compliance of the Guidelines and the **Para 10.88** of the
Report of the 5th ASFC (2016-20) and shall continue to rest with the Director, Municipal
Administration, Assam as well as Senior Most Secretary of the Urban Development Department.
4. The Deputy Commissioners shall submit the UCs to the Director, Municipal Administration, Assam. The
Urban Development Department as well as Director, Municipal Administration shall countersign the
UCs in the prescribed format (GFR 19-A) for submission of the same to Finance (EA)
Department, Assam Accountant General, Assam.
5. The expenditure is subject to observance of all financial rules, procedures and formalities, Calling of
NTF as per CVC Guidelines, and observance of the provisions of AFRBM Act, 2005.

The expenditure is debitable to the Head of Account - 2217-Urban Development-80-General-192-
Assistance to Municipalities Town Committees-5710-Devolution of State Finance Commission-70-
Municipalities-32-Grants under-99-Others" under Grant No. 34 for the year 2016-17.
