for ULBs in general areas under the award of Forth Assam State Finance
Commission during 2016-17 in General Areas.

Sir,

In pursuance to earlier letter cited above, I am directed to convey the revalidation of sanction of the Governor of Assam for an amount of Rs. 50.00 Crores (Rupees Fifty Crores) only for payment towards release of devolution fund for ULBs under the award of Forth Assam State Finance Commission during 2016-17 in General Areas in order to supplement resources of ULBs. A statement showing district wise breakup of amount etc. for each ULB is shown at Annexure-I (copy enclosed).

The sanction is issued based on the following categories:

- I. The amount that is being distributed to ULBs as per criteria recommended by 4th ASFC vide para 10.22 of its report.
 - II. The amount shall be drawn by DC / SDO of ULBs to act as DDOs and shall be disbursed to each of the ULBs in their accounts duly registered under PFMS and the amount shall be transferred through ECS after ascertaining that all pending Utilization Certificates of each releases under 4th Assam State Finance Commission has been submitted.
 - III. ULBs shall have overall responsibility for compliance of the guidelines and shall continue to rest with the Director, Municipal Administration as well as Sr. Most Secretary of the Urban Development Department.
- The ULBs shall submit the UCs to the Director, Municipal Administration, Assam. The Urban Development Department as well as Director of Municipal Administration shall countersign the Utilization Certificate in the prescribed format (GFR-19 A) for submission of the same to Finance (EA) Department.
