Sub : Sanction for release of 1st (First) installment of 2015-16 relating to General Basic grant under the award of Fourteenth Finance Commission for ULBs during 2015-16 (General Areas) No. UDD(M)201/2015/8 Dated Dispur the 21st January, 2016.

Sir,

I am directed to convey the sanction of the Governor of Assam to an amount of Rs.33,14,07,138/- (Rupees thirty three core fourteen lakh seven thousand one hundred thirty eight) only for payment to Municipal Boards / Town Committees for General areas in respect of 1st installment of 2015-16 relating to General Basic grant under the award of fourteenth Finance Commission for ULBs during 2015-16 (General Areas). **This amount may be utilized against schemes to be selected by Urban Local Bodies as per Guidelines GOI, MOF vide No.13(32)FFC/FC/2015-16 dated, 08.10.2015.** A statement showing District wise breakup of amount of each ULB is shown at Annexure -1)

2. The sanction is issued with the following conditions :-

1. The amount i.e. distributed to ULBs as per criteria recommended by 4th ASFC vide para 10.22 of its reports. This allocation is provisional (in the light of recommendation No. 9.72 of the 14th FC and the formula for distribution being followed is as per latest approved recommendations of 4th ASFC since 5th ASFC recommendations are not yet accepted) and this will be adjusted later on after acceptance of recommendation of the 5th ASFC in this regards

(i) The Director, Municipal Administration, Assam, Dispur who is declared as the DDO in respect of 14th FC funds shall draw and disburse funds to each of the ULBs in their accounts duly registered under PFMS and the amount shall be transferred through ECS.

(ii) The ULBs shall utilize the fund as per Guidelines of 14th FC and they shall be responsible for any violation of guidelines. The overall responsibility for compliance of guidelines shall continue to rest with the Director, Municipal Administration, Assam.

(iii) Utilization Certificates are to be submitted by the Chairpersons of MBs /TCs for the period of 2010-11 to 2014-15 alongwith photographs of completion of schemes to the Director of Municipal Administration, Assam who will submit UC duly countersigned by him to the Govt. for further necessary action.

The expenditure is debitable to the Head of Account " 3604-Compensation and Assignment to Local Bodies and Panchayat Raj Institutions 00- 200-Other Miscellaneous Compensations-5534 -Urban Local Bodies (award of 14th Finance Commission- 13th Finance Commission) General Basic grants - 32 - grants-in-aid - 705 - Municipalities and S/D - Non Plan General 99 - Voted" (Grant No.66) during 2015-16(3604-00-200-5534-705-32-99).
